4. Pre-bid meeting shall be held at Province Health Logistic Management Centre, Birendranagar, Surkhet at 12:00 PM, 2080.09.25 (AD 10 January 2024).

Electronic bids must be submitted to the office Province Health Logistics Management Centre, Karnali Province, Surkhet through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 PM on BS 2080/10/07 (AD 21 January 2024). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM (Local Time) BS 2080.10.07 (AD 21 January 2024) at the office of Province Health Logistics Management Centre Karnali Province, Surkhet. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1,75,000/- which shall be valid for 30 days beyond the validity period of the bid i.e. BS 2081/02/07, (in AD 20 May 2024)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
