- 1. The *Province Health Logistcs Management Centre surkhet* invites *electronic* bids from eligible bidders for the Procurement of Free essential medicine package-2 under National competitive bidding Single Stage Two Envelope procedures.
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

- 5. Pre-bid meeting shall be held at **Province Health Logistic Management Centre Birendranagar** Surkhet at 12:00 PM, 2080.09.25
- 6. Electronic bids must be submitted to the office Province Health Logistics Management Centre karnali Province Surkhet through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on 2080.10.08 Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 *PM* (*Local Time*) 2080.10.08 at the office of Province Health Logistics Management Centre karnali Province Surkhet Bids must be valid for a period of 90 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.6,46,000/- which shall be valid for 30 days beyond the validity period of the bid i.e. BS 2081.02.08, (in AD 21 May 2024)
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 9. In the case of discrepancies or error in bid documents, bid notice or any other document, purchaser reserve the right to amend and correct at any time.
